



# Scope of the PPP Cell

- To identify, conceptualize and create a shelf of projects in consultation with the line Departments and recommend approval of suitable projects for implementation on PPP route.
- To assist different Government Departments in preparing the pre-feasibility reports through consultants.
- To assist the respective Departments in preparing the Detailed Project Reports.



# Scope of the PPP Cell

- To appoint / select consultants to develop the projects in consultation with the concerned Department
- To help respective Departments to conduct the bidding process for selection of developers.
- To interact with the Government of India and other funding agencies for obtaining their support.
- To act as the nodal agency for capacity building for PPP in the state, conduct/recommend exposure visits and training programmed on PPP.



# Scope of the PPP Cell

- To develop internal evaluation guidelines in consultation with the respective Departments to evaluate and assess the projects whether the projects are to be funded by the State Government, or implemented with Private Sector participation.
- To recommend projects to Government of India for grants under Viability Gap Funding Scheme.
- To inspect, visit, review and monitor any PPP Project under implementation in the State.



# Progress achieved

- ◆ A PPP Cell has been set up in June 2007 in the Infrastructure Development Department headed by the Principal Secretary, IDD
- ◆ State Level Single Window Agency for PPP projects has been constituted under the chairmanship of the Chief Secretary, GOK.
- ◆ High Level Committee under the Chief Minister's chairmanship to approve projects above 50.00 crore.



# Progress achieved

- ◆ A District Level Committee headed by the Deputy Commissioner of the District has been constituted to co-ordinate and facilitate the implementation of Infrastructure Projects.
- ◆ State Level Single Window Agency recommended five Projects to the High Level Committee for approval and four projects have been approved by the HLC.
- ◆ Rs.1.00 crore released under P.D.F. to iDeCK.



# Progress achieved

Projects Cleared -

- ◆ Improvements to Dharwad-Alnawar-Ramnagar Road (SH-34).
- ◆ Construction of Expressway (State Highway, Special) from Outer Ring Road to International Airport in Devanahalli Taluk.
- ◆ Improvements to Chikkanayakanahalli-Tiptur-Hassan Road.



# Progress achieved

- ◆ Improvements to State Highway (SH-10) from Maharashtra Border to Andhra Pradesh Border Gulbarga District.
- ◆ 2<sup>nd</sup> Stage development of Karwar Port through Private Participation under “BOOT” concept:

- ◆ Successfully completed 2 batches of two days Training Programmes on PPP for Officers of various Departments in association with Administrative Training Institute, Mysore.
- ◆ 54 Officers from PWD, Ports, KRDC, BMRDA, Tourism (Dept & Corporation), Industries & Commerce, Agriculture & Marketing & KSRTC participated in the programme.





# Action Plan:

- ◆ Posting of ADB Consultants.
- ◆ Preparation of Shelf of Projects in consultation with the line departments.
- ◆ To conduct one-day workshop for Heads and Senior decision making Officers of various Departments and Agencies.
- ◆ To conduct 5 batches of Training Programmes for at least 125 Officers.
- ◆ District Level awareness camps for sensitising various line departments and agencies on PPP.

- ◆ Deputing Officers to other States/Countries to study the successful PPP projects.
