The Infrastructure Development Department was established in September 1996. The Infrastructure Development Department is mandated with the works mentioned below:

- (a) Developing infrastructure projects on Public and Private Partnership (PPP) basis and mainstreaming PPP mode of implementation.
- (b) Developing Airports and small Airstrips.
- (c) Coordinating with the Ministry of Railways to implement railway Projects.

In the Budget of 2017-18, **Rs.78999.00** lakhs have been provided vide revised estimates & restoration and reappropriation for Infrastructure Development Department. Budget. Expenditure towards various projects is shown below.

➤ In the year 2017-18, Budget allocation of Rs.3695.00 lakhs was made for Development of Minor Airports —Acquisition of Land. NEW INITIATIVES:

Providing Regional Air Connectivity:

Karnataka is one of the States in the country witnessing rapid economic growth due to the various Central and State level policy initiatives. These policy initiatives in turn have facilitated the development of industrial and allied infrastructure in the State, which have led to an increase in demand for better connectivity across the State. With this in mind, the State Government has been looking at various options for improving connectivity across the transport segment.

Over the last couple of years, Government of Karnataka (GoK) has been at the forefront in the development of airport infrastructure and promoting the aviation industry in Karnataka. The present airport at Bangalore, the Kempegowda International airport is the first airport to be developed with private sector participation in India. In addition to development of an International airport in Bengaluru, GoK has also enhanced capacities and infrastructure in airports at Mysore, Mangalore, Hubli and Belagavi.

For the improvement of air-connectivity within the State and to give a fillip to the economic development, Government of Karnataka has initiated development of green-field airports at Shimoga, Gulbarga, Vijayapura, Ballari and Hassan on a Public Private Partnership (PPP) framework. Gulbarga airport construction has been entrusted to State PWD for completion of balance works. Alternate mode for development of Shivamoga airport is being examined. AAI has been requested to take up development of Bijapur airport. Land acquisition is in progress for Ballari & Hassan airports. Efforts are also on to commence civil flight operations at the Defence Airport at Bidar under Regional Connectivity scheme.

The basic infrastructure for undertaking airline operations within the State is in place. GoK now intends to utilize this infrastructure to commence intra-state airline operations.
